Important Tax Deadlines

- March 15, 2023:** Filing for Partnerships & S-Corporations
- April 18, 2023:** 1st Quarter Estimated Tax Payment Due
- April 18, 2023:** Filing for C-Corporations and all other individuals
- May 1, 2023:** Filing of Personal Property
- June 15, 2023:** 2nd Quarter Estimated Tax Payment Due
- July 31, 2023:** Federal Excise Tax (Form 720)
- August 31, 2023:** Heavy Highway Use (Form 2290)
- September 15, 2023:** 3rd Quarter Estimated Tax Payment
- January 15, 2024:** 4th Quarter Estimated Tax Payment

Partnership or S-Corporation returns are due March 15th.

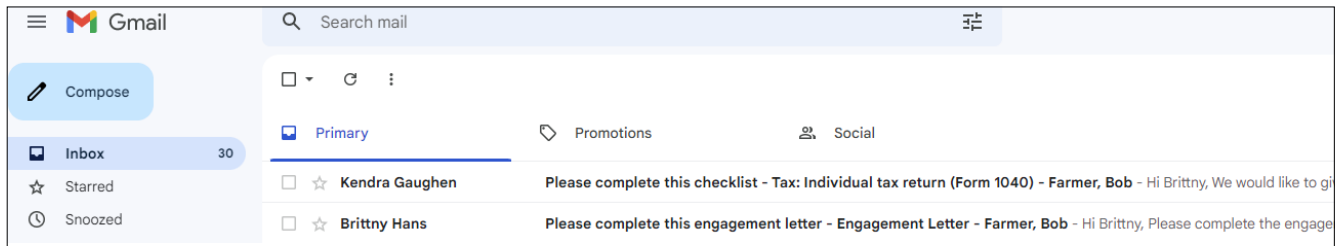

IPM Tips and Tricks

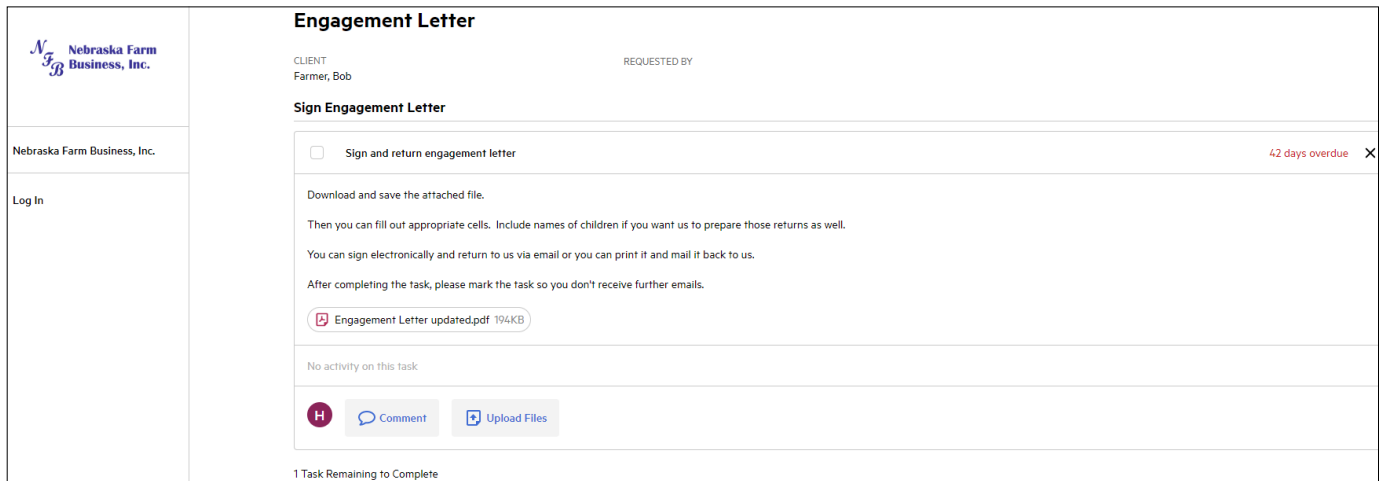

Tax Return Reminders

When you receive your 2022 tax return packet:

- Read the letter that is included, this will give instructions on paying your taxes or receiving your refund
- Sign your 8879 and return it to our office. We need this document to file your tax return. This form is also available to sign electronically
- If you would like to have an electronic copy of your return, please inform your consultant
- January 2024 estimate vouchers will be included in your packet
- Reminder, NFBI will no longer prepare tax returns for the March 1st deadline
- Tax returns will be completed on a first-come, first-served basis
